DESCRIPTION

SikaShield® E-3 sk/Safeguard (thickness 3 mm) is a self-adhesive elastomeric bitumen membrane reinforced with a woven glass. The top side is laminated with a white polypropylene fleece and the bottom side with a silicone peel-off film. The top side longitudinal overlap area has an onesided PET-foil edge strip and the opposite underside a safety seam foil strip.
