#### **DESCRIPTION**

SikaBlock® M976 EP is an epoxy tooling board with compact surface and high thermal stability.

#### **PRODUCT BENEFITS**

- Premium smooth and fine surface aspect
- Extremely low surface porosity minimizing surface finish/sealing
- High temperature resistance and dimensional stability
- Lightweight density
- Lower dust formation when milled
- Good mechanical strength and edge stability

#### AREAS OF APPLICATION

SikaBlock® M976 EP is designed for master models for composite molds made with prepregs in autoclave as well as for direct molds for composite prepreg parts in short series production.

It is also well suited for molds for thermoforming of plastic parts in short series production as well as for high accuracy composite parts or molds by wet lay-up or infusion pro-

This product is suitable for experienced professional users only. Tests under actual processing conditions and with additional materials such as fibres, coatings and release agents must be performed to proof material compatibility.

#### METHOD OF APPLICATION

## **Product preparation**

Before SikaBlock® M976 EP boards can be processed (machined) they must be conditioned to  $18\,^{\circ}\text{C} - 25\,^{\circ}\text{C}$ .

If the boards need to be bonded, make sure that the surfaces are clean, dry and free of grease or oil.

For bonding SikaBlock® M976 EP boards together use SikaBiresin® B176. Further details on the adhesives can be found in the respective Product Data Sheet.

#### **Application**

SikaBlock® M976 EP can be easily machined by milling, drilling, sawing or modified manually. It is recommended to use high performance tools to machine these boards.

For milling parameters check information from cutting tool manufacturers or get the General Guideline SikaBlock® Epoxy Boards for more information.

#### STORAGE CONDITIONS

The board needs to be stored flat over the entire surface in dry conditions.

Many models and tools are made of bonded boards, either with identical or other materials. Storage at low and elevated temperature can lead to high stresses due to the different expansion coefficients. To prevent this, it is necessary to store the models and tools at a temperature range between 15 °C and 30 °C.
