DESCRIPTION

SikaMelt[®]-197 is a versatile polyolefin based hot melt adhesive used for various lamination applications. Due to its long open time SikaMelt[®]-197 can be considered for lamination applications without heat reactivation.

PRODUCT BENEFITS

- Good heat resistance
- Long open time
- Simple processing

AREAS OF APPLICATION

SikaMelt[®]-197 has very good adhesion properties on polypropylene. It is also suitable to bond wood, textiles, non-woven materials and foams.

This product is suitable for experienced professional users only. Test with actual substrates and conditions have to be performed to ensure adhesion and material compatibility.

CURE MECHANISM

SikaMelt®-197 is a physically hardening adhesive.

CHEMICAL RESISTANCE

SikaMelt[®]-197 is resistant to aqueous surfactant, weak alkaline/ acids solutions and temporarily resistant to fuels, solvents and mineral oils.

The chemical resistance is influenced by several factors such as chemical composition, concentration, period of exposure and temperature. Therefore a project related testing in case of chemical or thermal exposure is required.

METHOD OF APPLICATION

Surface preparation


Surfaces must be clean, dry and free from grease, oil and dust.

Application

With adequate processing equipment SikaMelt®-197 can be applied as film, dot, bead or spray application. When dispensing SikaMelt®-197 from drums, for applications by slot die or spraying device, first transfer the material to an intermediate tank avoiding air entrapments.

For automated applications a suitable filter system is required.

To meet the required application properties the adhesive viscosity can be adjusted by adapting the application temperature (see diagram 1).



During breaks SikaMelt[®]-197 is to be processed as follows:

For breaks \geq 1 h the heating needs to be lowered to 80 °C and for breaks \geq 4 h the heating needs to be switched off.

To guarantee a constant quality during the whole production process it is mandatory to protect the adhesive in the melting tank with nitrogen or carbon dioxide (to avoid possible reaction of the product with oxygen).

For advice on selecting and setting up suitable processing equipment contact the System Engineering Department of Sika Industry.

Removal

Equipment and application tools can be cleaned with SikaMelt[®]-005 (see also Cleaning Instructions).

SikaMelt[®]-197 may be removed from tools and equipment with Sika[®] Remover-208 or another suitable solvent.

Hands and exposed skin have to be washed immediately using Sika® Cleaner-350H or a suitable industrial hand cleaner and water. Do not use solvents on skin.

STORAGE CONDITIONS

SikaMelt[®]-197 has to be stored at temperature below 40 °C in a dry place.

For transportation purposes, the storage temperature can be exceeded for a period of max. 4 weeks up to 60 °C.
